## Chief's Monthly Report -October

Troy Maloney, Fire Chief

As this is written on Wednesday, October 26<sup>th</sup>, additional updates will be provided at the next Board meeting.

Personnel: With the addition of FF Quinn becoming a Paramedic, effective November 8<sup>th</sup>, both stations on all three shifts will have advanced life support medics assigned to the engines.

Our annual Dive Rescue class is being held this Friday, Saturday and Sunday. There are 15 students attending from the region. This is an advance rescue diver class that will consist of classroom education and actually dives in the river, Lake Havasu and a CRIT canal.

Chief Maloney will be out of the office from October 28<sup>th</sup> through November 3<sup>rd</sup> and available by phone and email. Captain Pellerin will be in command of the District in the Chief's absence.

Apparatus: 1102 is back in service from warranty work at Freightliner in Phoenix.

1132 was at a wildland fire assignment in Wyoming and is now back in-service.

Boat-1 outdrive is being repaired.

Facilities: Repairs were made to the diesel exhaust venting system at station 11.

The station 11 inspection was completed by AmeriSpec on Oct 23<sup>rd</sup>. We are awaiting the final report.

Incidents: Oct. 2<sup>nd</sup> at 2:30 PM, 1151 with POC Anderson and FF Quinn responded to CRIT to dive on a vehicle in the canal. No victims were found and a stolen vehicle was recovered.

Oct 3<sup>rd</sup> at 7:00 PM, 1100, 1101 and 1102 respond to the area of Pirates Den for a swift water rescue from a flash flood on Riverside Drive. 1101 and 1100 arrived to find a car stuck in the middle of flood waters with one occupant who had self-rescued and was not injured.

Oct 9<sup>th</sup>, 1100 and 1101 responded along with Parker FD and CRIT FD to a reported structure fire at the River View RV park off of Parker Dam Road in Earp, California. 2200 arrived with CRIT FD to find the fire out and cancelled BFD units.

On Oct 10<sup>th</sup>, our crew at station 11 taught fire extinguisher operations to three classes of La Paz County employees.

On October 26<sup>th</sup>/27<sup>th</sup>, Boat-1 will be participating in video/photo shoot for Speedboat Magazine. Speedboat Magazine is donating their time and this video to the Parker Chamber of Commerce.

Call volumes have been low as we are transitioning between the summer and winter crowds.

Finances: We are working on creating a Capital Improvement Plan (CIP) Depreciation Funding Schedule for FY 2019/2020. This will add us in planning for needed capital expenditures in the future. The long-term plan is to put the District in the financial position to pay cash and not use credit for purchases, thus limiting debt.

The covered storage area at station 11 has been repaired. We are looking for a possible grant to replace it with an enclosed steel building where we can store our apparatus and equipment securely.

Administration: Working on completing the new policy manuals.

We are evaluating our current pay scale and finding many discrepancies within the scale itself. We are working on a revision to the pay scale to present to the Fire Board for approval.

Oct 12<sup>th</sup>, met with La Paz County Supervisor Duce Minor.

Oct 17<sup>th</sup>, met with Dee Dee Wright with Gila Communications/Motorola about fire radio system.

Oct 22<sup>nd</sup>, attended the La Paz County Fire Chief's meeting which was held in Ehrenberg.

Oct 23<sup>rd</sup>, met with Luke Messer with the Arizona Department of Environmental Quality in regards to our opening burning permit processes.

Oct 24<sup>th</sup>, met with Parker Fire Chief Ralph Beard to discuss mutual aid responses.

The Arizona Department of Transportation and the Federal Highway Administration are working to repair 7 miles of pavement on State Route 95 in Parker. The project is located on the Colorado River Indian Reservation. Work is scheduled to occur between Beacon Road (milepost 148) and East Riverside Drive (milepost 155). The project will remove and replace pavement, install rock protection fence and reconstruct guardrail. In addition, the work includes replacing the existing pavement markings, replacing embankment curb and other miscellaneous work. The project is scheduled to begin in winter 2018 with completion anticipated in fall 2019. The project area is on State Route 95 between Beacon Road (milepost 148) and East Riverside Drive (milepost 155).

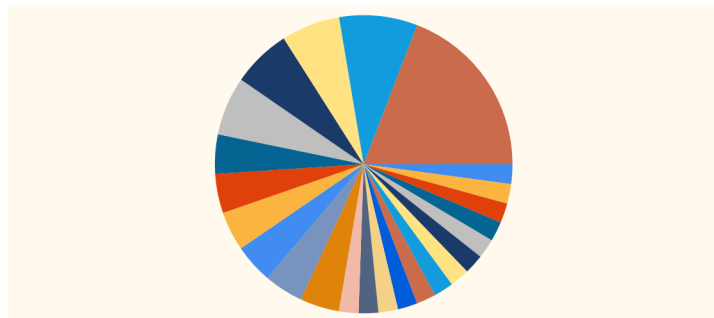
